

## WEDDING PHOTO BOOTH RENTAL PACKAGE

This Photo booth Agreement is made by and between Creat LLC ("weddingphotoboothrental.org"), with its principal place of business at W246N6700 Champeny Ct, Sussex, WI 53089 and \_\_\_\_\_ ("Customer"). Customer wishes to retain a photo booth rental and agrees to do so under the terms and conditions set forth in this Agreement; as follows :

### Section 1. Packages

Groupon (\$450 value) – Package includes 3 hour rental with unlimited photo stripes during the 3 hour rental, onsite photo booth attendant, and an online gallery to be posted by Creat LLC.

#### Initial

\_\_\_\_\_ I acknowledge I have purchased a Groupon or paid the equal amount directly to Creat LLC.

Upgrade Package (\$150 extra) – Package includes an additional hour of rental, hard copy of photos that will be put onto a disc, rental of prop box, photo album, and decorative materials for album.

### Section 2. Payment Schedule.

Groupon must be redeemed to retain desired date. Groupon does not include WI state sales tax or any upgrade expenses. Remaining balance must be paid in full within 60 days of securing date. Failure of payment within 60 days may result in loss of desired date.

Any funds collected before date of event go into a retainer fee.

**\*\*\*Creat LLC Liability is equal to deposit price\*\*\*If the final payment is received after the event, a fee of \$75.00 will be added to the final balance. \*\*\*Returned check fee is \$40.00. \*\*\* Retainer is NON-REFUNDABLE.**

#### **Section 4. Space and power requirements**

Customer is required to provide the following: Photo booth must have a 12ft x 12ft space with access to power within 20 feet.

All booths are designed to fit within a standard door frame and elevator. If venue does not have an elevator and photo booth is required to be taken upstairs customer will be billed an additional charge of \$50.

#### **Initial One**

#### **Section 5. Liabilities**

Customer takes full responsibility for any injuries, misuse or misbehavior in, on, or around photo booth.

#### **Section 6. Stolen or damaged items**

All equipment for photo booth is inspected before event and will be in proper working order. Customer is responsible for any damage caused by guests to equipment. If a prop box is provided in package to event customer is liable for any stolen or misplaced products.

#### **Section 7. Rights to product**

Creat LLC has the rights to all photographs and designs to use for any marketing materials or promotions.

#### **Section 8. Travel**

All rentals include travel within 30 miles of Sussex, WI 53089. Any travel required outside of the 30 miles will be billed at \$1.5/mile.

#### **Section 9. Setup, Takedown, and Run Time**

Setup: If venue allows photo booth attendant will arrive approximately an hour and a half before booth is scheduled to operate. In the event an early setup is not available the attendant will setup in designated area as discreetly as possible.

Takedown: Takedown will begin immediately after rental time has expired. If a photo album was purchased it will be placed on gift table at the end of the rental.

Run time: Run time follows the requested time above in section 3. **Any unused rental time is NON-REFUNDABLE nor prorated.**

#### **Initial**

\_\_\_\_\_ I acknowledge that Creat LLC is not responsible for lost or stolen photos or albums.

Setup and takedown is not included as part of the hourly rental. There is no charge for setup and takedown.

**Section 10. Notifications**

Customer must give a two week notice to Creat LLC with any changes to contact information.

**Section 10. Termination of Agreement.**

Customer termination of agreement results in loss of retainer. If customer needs to change the date of the event, the Groupon funds may be transferred to a different date if that date is available.

*Gratuity is not included in the overall price. It is strongly encouraged and appreciated that if your attendant does an amazing job to tip him/her, industry standard being approximately 10%.*
